Carbon Audit Services




A carbon audit (or carbon footprint calculation) is the process of calculating the greenhouse gas emissions emitted by a company, supply chain or individual product.

This has been the key Emission Statement service since 2006.

Emission Statement undertakes carbon audits using the GHG Protocols (diagram below) as determined by the World Business Council for Sustainable Development and to the standards of ISO 14064-1.

Auditors are Registered Greenhouse and Energy Auditors with the Australian Government Department of Climate Change and Energy Efficiency.

The Carbon Audit Process



Scoping of the Project Parameters

Before beginning the carbon audit, the project parameters must be finalised. This includes determining which businesses, departments, sites or products are to be audited. Calculating the carbon footprint for legislative reporting purposes require different data requirements than audits undertaken for other purposes.

2 Data Collection

The collection of data is a key component of the carbon audit process. Emission Statement assists clients with data collection through resource requirements as necessary, its close association with energy providers and easy-to-use templates.

Energy Walkaround & Carbon Reduction Analysis

Emission Statement will undertake inspections of key premises within the scope of the project and build a list of possible carbon reduction and energy cost reduction measures. All carbon reduction measures are then analysed and listed according to efficiency and ongoing abatement cost.

Final Report & Recommendations

The final carbon audit report contains, but is not limited to:

Detailed carbon footprint overview

Detailed explanation of emissions sources

Benchmarking across sites and brands

Detailed carbon reduction recommendations and payback periods

Detailed outlines of cost reduction opportunities

Celebrate Achievements & Create Self Sufficiency




- O Recognise and communicate initiatives undertaken

Supply Chain Services



No one company is responsible for all of its own carbon and environmental impacts. Analysis of full supply chains enables visibility of a company's total attributable emissions – and offers further opportunities for ongoing cost and energy reductions.

Supply chain



Company supply chains often consume large amounts of unnecessary fuel and energy due to deficiencies in their network structure.

This leads to increased costs, and an increased environmental impact.

Emission Statement uses specific tools to quantify the cost and energy drivers across networks, test alternative distribution and network design methods and develop plans for modification.

Emission Statement can also assist companies in delivering a greater focus on sustainability from suppliers through Green Purchasing and Sustainable Supply policy documents.

Large businesses are benefiting greatly from introducing strict sustainability principles in to their buying decisions – whereas small suppliers with a sustainability focus are now able to compete with bigger players.

In order to ensure the correct amount of offsets were being purchased, Emission Statement undertook an independent carbon supply chain audit that created the baseline for Arlec's endeavours.
